About PROXESS Registry Setup

Specifications saved in the Windows system registration are required for the complete configuration of PROXESS which corresponds to your requirements. PROXESS Registry Setup is available to you so that you do not need to manually enter the corresponding values in the Windows registration editor. With this program, you save the desired values for the various different PROXESS server modules.

Which modules do you have to register?

For the server modules (Document Manager and Database manager), registration is required in any case. For the Event Log Agent, on the other hand, registration is only required if you have installed this module.

Can you change values in the registration?

You should only change values in the registration if you are completely sure that it will not cause systems errors. If in doubt, contact your supplier for support. Errors in the registration can lead to your PROXESS system no longer working properly.

Install menu




Figure: "Install" menu

Using the commands in the "Install" menu, you can set up the registration branches for the individual PROXESS modules. You can quickly and easily fully delete the registration of a PROXESS module later on using the commands. Also read the corresponding step-by-step instructions in the help information for this.

As soon as you have set up a registration branch, a check mark appears in front of the corresponding command in the "Install" menu. You can then edit the registration values of the branch. As long as this has not yet been done, the commands in the corresponding menu are inactive.

Tip



The default values for registration are not automatically set when the registration branches are set up. For this purpose, select the command from the desired menu and accept the specifications.

You can configure the Storage Manager using the Storage Manager Explorer.

How to set up a registration branch

You cannot make the registration settings for a PROXESS module until you have set up the corresponding registration branch in Registry Setup.

1. In the "Install" menu, select the registration branch which you would like to set up. The "Registry Values" dialog box opens.
2. In the **Do you want the registry** option group, activate the **set up option**. This option is already activated by default.
3. Close the dialog box with **OK**.

There is now a check in front of the selected registration branch in the "Install" menu. You can now carry out registration for the corresponding PROXESS module.

How to delete a registration branch

With Registry Setup, you can quickly and easily delete the entire registration of a PROXESS module again if necessary.

1. In the "Install" menu, select the registration branch of the PROXESS module whose registration you would like to fully delete. The "Registry Values" dialog box opens.
2. In the **Do you want the registry** option group, activate the **delete** option. This option is already activated by default.
3. Click **OK**. A security prompt appears. Confirm this with **Yes**.
4. The check in front of the selected registration branch in the "Install" menu has now disappeared, and the commands in the corresponding menu are inactive again.

License command




Figure: "Database Manager License" dialog box

Store the path to the license file for the PROXESS Database Manager. The License.txt value is specified first by default. If you accept this value, PROXESS searches the license file in the working directory in which the PROXESS Database Manager is located. If the PROXESS server is to be started as a service, the absolute file path must be entered at this point (example: c:\programs\proxess\license.txt).

You can select the license file using the button. Note that you can then only successfully start the Database Manager if the corresponding license file is specified.



If the Database Manager is to be started as a service, you have to enter the absolute path here (e.g. C:\Proxess\License.text).

With this value, you can specify where the RPC log file is output:

3	DbWin32 and log file

DbWin32 is a small shareware program which you can obtain from our support department if necessary. Changes are also detected by the Database Manager during operation. For this reason, stopping and starting the service is not necessary. If logging has to be activated, we recommend outputting to a file, as this is easier for the support department of your supplier to handle.




Fig.: Database Manager menu, Logging

Using this value, you can limit the output of exceptions in the log file to specific magnitudes.

SevDumpLevel	Magnitude	Probable originator
0	Recoverable	Client, Document Manager or Storage Manager
1	ClientFailure	Document Manager or Storage Manager
2	Resources exhausted	Memory fault, no database connections, etc....
3	Database failure	Relational database or full-text database (exclusive syntax error or timeouts)
4	DbilFailure	Internal error in the Database Manager

As you can see in the table, the numerical value of the magnitude is a scale for the severity of the error which occurred:

Recoverable exceptions occur if a syntactic error is committed or a timeout expires during a database query, for example.

An exception with the magnitudes DatabaseFailure or even DbilFailure indicate a serious problem whose cause should be cleared up in any case.

For this reason, you can only specify the minimum magnitude from which exceptions are also logged, e.g. SevDumpLevel = 2 means that exceptions are recorded with the magnitudes ResourcesExhausted, DatabaseFailure and DbilFailure.

You cannot limit the output of information and start & stop times.




Figure: "Database Manager RPC Log –Local PC, General"




Figure: "Database Manager Error Log –Local PC, DB-Win"




Fig.: Error log for Database Manager (tab: General)

For this value, you declare the desired path name of the exception log file. The selected directory must already exist before program startup.

If you enter a valid path name, the starting and stopping of the Database Manager, at a minimum, is also logged regardless of the selected output medium.




Figure: "Database Manager Error Log –Local PC, File"




Figure: "Database Manager Error Log –Local PC, Console"




Figure: "Database Manager RPC Log –Local PC, DB-Win"




Figure: "Database Manager Error Log –Local PC, File"




Figure: "Database Manager Error Log –Local PC, Console"




Figure: "Database Manager Relational Database" dialog box




Figure: Database Manager Settings dialog box




Figure: Dialog box for logging in the Database Manager




Figure: Update tab (SQL)




Figure: "Database Manager RPC Settings" dialog box

Communication protocol

Communication between the Document Manager and the Database Manager or between the Storage Manager and the Database Manager is carried out through "remote procedure calls" (RPCs). For this value entry, you specify the network protocol on the basis of which Database Manager accepts network requests. This value must match the protocol with which the Document Manager and the Storage Manager attempt to address the Database Manager.

The following protocols are available for selection:

This value entry specifies a lower estimate for the maximum number of remote procedure calls which the Database Manager can handle at one time. The RPC runtime library guarantees that the server allows at least the desired number of simultaneous function calls. For this purpose, a queue in which space for a corresponding number of sub-processes is reserved is already created when the program is started up.

If the load on the system exceeds the announced maximum load, the RPC runtime library automatically enlarges the queue. Sub-processes which are no longer required are reduced back to the specified limit when the system load is lower, however.

Warning information

	<p>Should the load on the system increase so much that sub-processes can no longer be increased quickly enough to cover demand, an error message such as the following may be output:</p> <p>"The RPC server is too busy to complete this operation." (error code: 1723)</p> <p>Only in this case should this value entry be changed in coordination with PROXESS support of your supplier.</p>




Fig.: Selection dialog for the full-text database




Fig.:General Full-Text Settings




Figure: "Document Manager" menu




Figure: "Document Manager License" dialog box




Figure: "Document Manager User Login" dialog box




Figure: "Document Manager Settings" dialog box




Figure: "Document Manager Network" dialog box




Figure: "Session License Manager" dialog box




Figure: "Document Manager" menu




Figure: "Document Manager RPC Log –Local PC"




Figure: "Document Manager Error Log –Local PC"




Figure: "Document Manager Error Log –Local PC, DB-Win"




Figure: "Document Manager Error Log –Local PC, Console"




Figure: "Document Manager Error Log –Local PC, File"




Figure: "Document Manager Log –Local PC, File"




Figure: "Document Manager Log –Local PC, DB-Win"




Figure: "Document Manager Log –Local PC, Console"




Figure: "Document Manager Security Log –Local PC"




Figure: "Document Manager Security Log –Local PC, File"




Figure: "Document Manager Security Log –Local PC, DB-Win"




Figure: "Document Manager Security Log –Local PC, Console"




Figure: "Document Manager Active Queries" dialog box




Figure: "Document Messaging" dialog box




Fig.: Dispatcher dialog




Fig.: Selection of the full-text database for the PROXESS system




Fig.: Full-text settings for Apache Solr




Figure: "Computer Name Command" dialog box
